INSPECTIONS

Did you know that OSHA refers to the ANSI specifications when dealing with aerial work platforms? ANSI A92.6 Manual of Responsibilities for owners and operators states, "The owner of an aerial platform shall ensure that an annual inspection is performed on the aerial platform no later than thirteen (13) months from the date of the prior annual inspection. The inspection shall be performed by a person(s) qualified as a mechanic on the specific make and model of the aerial platform."

Also, if a malfunction / problem is detected, "the owner shall not place the aerial platform into service until all malfunctions / problems have been corrected," says the ANSI Manual.

Allowing a qualified lift technician to perform annual inspections on your lifts protects the safety of your employees and protects your company against OSHA violations and expensive liabilities that could result from an accident involving your aerial equipment.

MAINTENANCE

Preventive Maintenance Programs
The best way to ensure the life of your aerial platform and prevent minor problems from turning into costly repairs is the use of a regular preventive maintenance program. By servicing your aerial platforms at regular intervals, you will be assured of limited downtime, maximum productivity and most importantly, safety.
